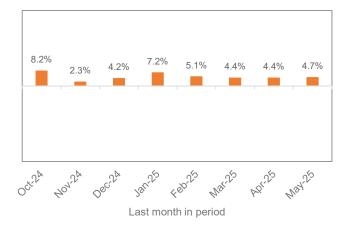

#### **QUICK FACTS**

LA County new retail light vehicle registrations increased 4.1% during the first five months of this versus year earlier. U.S. market was up 7.3%. The county market improved 3.6% in April and May of this year combined versus the same period in 2024. Registrations declined in May of this year versus year earl-er

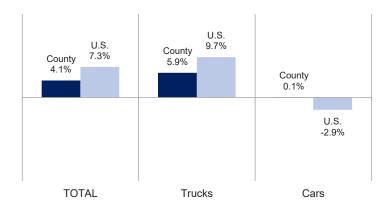
Electric vehicle market share has declined so far this versus year earlier. Hybrid vehicle share reached 19.2% (see page 4).

#### **Data Information**

Data presented in Auto Outlook measures new retail vehicle registrations in Los Angeles County. Monthly recording of registrations occurs when vehicle title information is processed, which June differ from date of sale. Title recording can occasionally be subject to processing delays by governmental agencies. For this reason, the year-to-date figures will typically be more reflective of market results

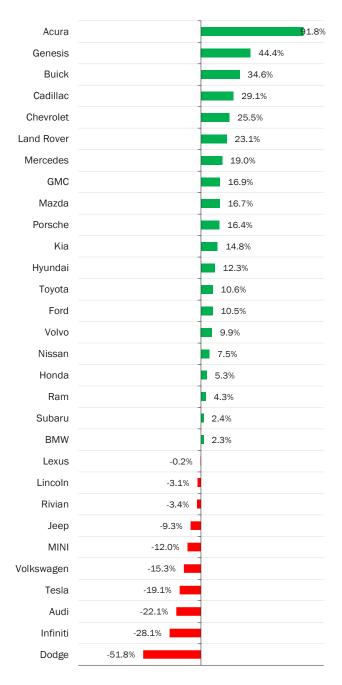

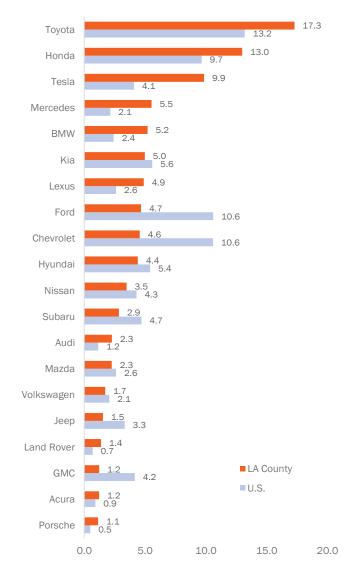


#### Percent Change in Registrations YTD '25 thru May vs. Year Earlier (Top 30 selling brands)





#### County and U.S. Market Share YTD '25 thru May (Top 20 selling brands in county)

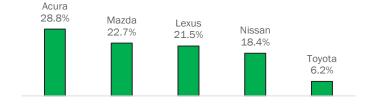

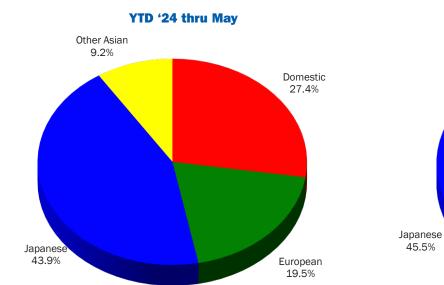

#### Market Share for Japanese, Domestic, European, and Korean Brands

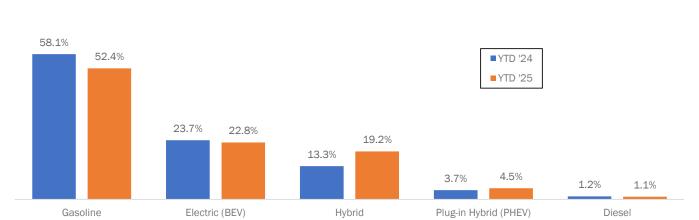
